### ORDINANCE TO APPOINT ALTERNATE MEMBERS FOR BOARD OF REVIEW

#### SECTION I – TITLE AND PURPOSE

This ordinance is entitled the Town of Lac du Flambeau Ordinance to Appoint Alternate Members for Board of Review. The purpose of this ordinance is to provide, upon lawful removal of named members, alternate persons to serve as replacements to the Board of Review for the Town of Lac du Flambeau.

#### SECTION II – AUTHORITY

The Town Board of the Town of Lac du Flambeau, Vilas County, Wisconsin, has the specific authority under s. 70.47(1) and (6m)(c), Wis. Stats. to remove members from and to appoint alternate members to the Board of Review for the Town of Lac du Flambeau.

#### SECTION III – ADOPTION OF AN ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting, and proper notice having been given, provides for the removal of members of the Board of Review for the Town of Lac du Flambeau and the appointment of alternate members.

#### SECTION IV – MANNER OF APPOINTMENT

- A. The Town Board of the Town of Lac du Flambeau, Vilas County, Wisconsin, by this ordinance, establishes and shall maintain a public list of names of persons eligible and appointed by the town board to serve as alternate members of the board of review. The list shall be arranged and maintained by the town clerk in a priority order of probable and likely service as an alternate. Because the Town of Lac du Flambeau has an appointed Town Clerk, and said Clerk is a resident of the Town of Lac du Flambeau, the Clerk shall permanently be appointed as Alternate #1 to fill the vacancy of an elected clerk, and will serve at all board of review sessions (unless lawfully removed) as a citizen member of the board of review.

B. When lawful removal of a board of review member has been requested which results in there being fewer than the required three members on the board of review, the town clerk shall request the next available alternate member to serve so that the requirement for a minimum of three board of review members is met.

The following electors of the Town of Lac du Flambeau are named as alternate members of the board of review, to serve in the order indicated:


Alternate 1: Nancy Edwards (to serve at all board of review sessions)

This ordinance is effective upon publication or posting. The town clerk shall properly post or publish this ordinance as required under 60.80, Wis. Stats.




