## **ORDINANCE 86-4**

### **DESIGNATING CURFEW**

#### **I. INTENT AND AUTHORITY**

**1.01 TITLE.** An Ordinance respecting the designation of a curfew.

**1.02 INTENT.** The intent of this Ordinance is to provide an aspect of health, safety and welfare for the community by requiring persons under the age of 18 years to be off of the streets at a reasonable hour each night.

**1.03 STATUTORY AUTHORITY.** This Ordinance is adopted pursuant to Wisconsin Statutes authorizing towns with village powers to adopt ordinances pertaining to health, safety and welfare.

**1.04 INTERPRETATION.** In their interpretation and application, the provisions of this Ordinance shall be held to be minimum requirements and shall not be deemed a limitation or repeal of any other power granted by the Wisconsin Statutes.

**1.05 ABROGATION AND GREATER RESTRICTIONS.** It is not intended by this Ordinance to repeal, abrogate, annul, impair or interfere with any existing rules, regulations, ordinances or permits previously adopted or issued pursuant to law. However, whenever this Ordinance imposes greater restrictions, the provisions of this Ordinance shall apply.

**1.06 SEVERABILITY.** Should any portion of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected.

**1.07 APPLICABILITY.** The provisions of this Ordinance shall apply to all persons who are under the age of 18 years in the Town of Lac du Flambeau.

#### **II. CURFEW TIMES**

##### **2.01 EFFECTIVE HOURS**

No child under the age of 18 years shall be out of doors at the following times:

a. between the hours of 9:00 pm and daylight during the period when Central Standard Time is in effect

b. between the hours of 10:00 pm and daylight when Daylight Savings Time is in effect

**2.02 EXCEPTIONS TO CURFEW**

The curfew established above shall not apply in the following circumstances:

- a. the child is accompanied by a parent or other adult with the consent of a parent
- b. the child is over 14 years of age and is engaged in employment, or traveling to or from employment.
- c. the child has attended a school, town, tribal, or community event at which children are allowed, and it is within one hour of the termination of the event.
- d. emergency circumstances require the child to be out of doors.

**III. EFFECTIVE DATE**


This Ordinance shall take effect upon passage and publication as provided by law, and shall remain in effect until repealed by the Town Board of the Town of Lac du Flambeau.
