Town of Lac du Flambeau Ordinance 93-1B

BOATING ORDINANCE

A SOLE ORDINANCE TO REGULATE BOATING UPON THE WATERS OF THE TOWN OF LAC DU FLAMBEAU, VILAS COUNTY, WISCONSIN, AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

The Town Board of the Town of Lac du Flambeau does ordain as follows:

- A. The provisions of this Ordinance shall apply to those waters within the jurisdiction of the Town of Lac du Flambeau.
- B. This Ordinance shall be enforced by any authorized Law Enforcement Officers of the Town of Lac du Flambeau, or any other designated law enforcement officer.
- SECTION II. Intent

The intent of this Ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests, and the capability of the water resources.

SECTION III. State Boating and Safety Laws Adopted

State boating Laws as found in ss.30.50 to 30.71, Wis. Stats., are adopted by reference.

No person shall operate a boat faster than "slow-nowake" on these stated lakes between the hours of 8:00 p.m. and 10:00 a.m. local time.

SECTION VII. Speed Restricted Channels, Rivers and Streams

No person shall operate a boat faster than "slow-nowake" in any river stream in the Town of Lac du Flambeau. No person shall operate a boat faster than "slow-no-wake" in the following channels between: AT ALL TIMES

North Twin Placid and South Twin Placid Lakes North Twin Placid and Fence Lakes Fence and Crawling Stone Lakes Crawling Stone and Little Crawling Stone Lakes Crawling Stone and Long Interlaken Lakes To-To-Tom and Long Interlaken Lakes Flambeau and Pokegama Lakes Moss and Long Interlaken Lakes Gunlock and Shishebogama Lakes Upper Sugarbush and Middle Sugarbush Lakes Middle Sugarbush and Lower Sugarbush Lakes White Sand and Little Sand Lakes

SECTION VIII. Water Skiing - Restricted Hours on All Waters

No Person shall water ski or operate any motorboat towing a person engaged in water skiing or similar activity during the hours of 8:00 p.m. or sunset, whichever comes first, and 10:00 a.m. local time.

SECTION IX. Posting Requirements

This Ordinance or information contained within this Ordinance shall be prominently posted by the Town of Lac du Flambeau as required by s.30.77(4), Wis. Stats.

SECTION X. Penalties

Wisconsin state boating penalties as found in s.30.80, Wis. Stats., are adopted by reference. Violations of this Ordinance, or any subsequent revisions thereof, will be treated as prescribed in Ordinance 95-02A, an Ordinance Relating to Issuance of Citations for Violations of Ordinances.

SECTION XI. Severability

The provisions of this Ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this Ordinance or the application to any person or circumstances is held invalid, the remainder of the Ordinance and the application of such provisions to other persons shall not be affected.

SECTION XII. Effective Date

This Ordinance shall be come effective upon passage and the day after publication of the Notice of Adoption as prescribed by law.
