

June 20, 2018 Regular Town Board Meeting

The regular meeting of the Town Board was called to order by Chairman Gaulke at 1:00 p.m. Supervisor Robert Hanson, Supervisor Chris Mayer, Treasurer Irene Messinger, Clerk Nancy Edwards were present. Others present: Abbey McEnroe from the Lakeland Times, Eric Johnson from FYI News, Kay Hoff, Jim Sommerfeldt, Scott Harod, Tom Wegner, Sue Ackland, Gary Szychlinski.

This meeting was properly posted and the media notified as required by law.

Pledge of Allegiance:

Motion by Mr. Mayer and seconded by Mr. Hanson to approve the agenda.

Motion carried.

Motion by Mr. Hanson seconded by Mr. Mayer to approve voucher numbers 50537-50562 from the General Fund, voucher numbers 1751-1753 from the Ambulance Fund. Motion carried.

Motion by Mr. Mayer seconded by Mr. Hanson to approve the minutes of the June 6, 2018 Regular Town Board Meeting. Motion carried.

Treasurer Messinger provided her report on the financial status as follows:
Un-reconciled balance of the General fund as of 06/15/2018 as \$984,093.84.
Un-reconciled balance of the Ambulance Fund as of 06/15/2018 as \$476,017.60. A check of \$14,321.33 was received for the recycling grant. Motion by Mr. Mayer seconded by Mr. Hanson to accept the treasurer's report as presented. Motion carried.

Public comment on agenda items: None

Approval Liquor/Tobacco Licenses: Mr. Gaulke stated that the Joint town/tribal liquor committee met and approved the applications. There is also one picnic license added for the 4th of July for the American Legion. These applications also go to the tribal council on June 26, for approval. Motion by Mr. Hanson seconded by Mr. Gaulke to approve the applications as presented. Motion carried. Mr. Mayer abstained as one of the licenses is for his establishment.

Zoning Statistic report for 2017: Sue Ackland reported on the zoning statistics for 2017. She stated it was another good year with 29 new homes being built. This year she is already getting a good start. Mr. Mayer stated it would be nice to get the county's zoning department's statistic report to compare Lac du Flambeau to the other townships. Lac du Flambeau is reported to have more permits and value than any other town in Vilas County. It would be nice to have the county send someone over to do the county permits for Lac du Flambeau as they had in the past but because of budget cuts that personal was eliminated. Motion by Mr. Mayer seconded by Mr. Hanson to approve the zoning report. Motion carried.

Bartenders License: Applications were received by Jacob Maulson, Emma Iwachniuk, Jennifer Wilcox, Ann M. Kleiman-Zeller, Autumn Poupart, Mary Poupart. Motion by Mr. Mayer seconded by Mr. Hanson to approve the applications as presented. Motion Carried.
